That the City Clerk shall publish on the City's website and elsewhere as the Mayor may direct a request for citizen volunteers to make themselves available for appointment to the City's Planning and Zoning Commission and to other boards and committees as may hereafter be designated by the Mayor.

SECTION 2. That the City Clerk shall receive expressions of interest from citizens who volunteer to make themselves available for appointment and shall maintain a list of such citizens.

SECTION 3. That the Mayor select highly qualified citizens from the list of available citizens maintained by the City Clerk for appointment to the Planning and Zoning Commission or to other boards, committees or commissions as may hereafter need the services of citizens.

SECTION 4. That the name of any person so appointed by the Mayor be placed on the agenda of a Workshop meeting of the Board of Aldermen for consideration by the Board.

SECTION 5. That the name of any person so appointed and considered by the Board in a Workshop meeting may thereafter be placed on the agenda of a Regular meeting of the Board of Aldermen scheduled no sooner than 14 days after the Workshop meeting when the person was first considered. At such Regular meeting the Board may vote whether to approve the person's appointment or not.

SECTION 6. That once approved by a vote of the majority of the Board of Aldermen the appointment is thereby confirmed and the person may be sworn in to the office to which he or she has been appointed.

WHEREAS, LOU FUSZ Chevrolet, 5120 North Service Road, St. Peters, MO, was an authorized vendor under the MODOT cooperative purchase agreement;

WHEREAS, LOU FUSZ Chevrolet was requested to order for purchase one 2015 Chevrolet Silverado 1500 4WD double Cab LS pick-up truck (“the Truck”) for the City of Dardenne Prairie;

WHEREAS, the Board of Aldermen finds and determines that it is in the best interest of the residents of the City of Dardenne Prairie to purchase the Truck from LOU FUSZ Chevrolet for the sum of \$30,264.00 according to terms of the “Vehicle Buyers Order” document dated 04/27/15 and presented to the City of Dardenne Prairie for approval and signature;

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF DARDENNE PRAIRIE, MISSOURI, AS FOLLOWS:

SECTION 1. VEHICLE BUYERS ORDER

A. That the form, terms, and provisions of the purchase order styled “Vehicle Buyers Order” dated 04/27/2015, marked as **Exhibit A**, attached hereto and incorporated by reference herein, by and between the City of Dardenne Prairie, Missouri, and LOU FUSZ Chevrolet, be and hereby are approved and the Mayor is hereby authorized and empowered to execute, acknowledge, deliver

and administer on behalf of the City said Vehicle Buyers Order in substantially the form attached hereto.

B. That the Mayor is hereby further authorized and directed on behalf of and in the name of the City to agree to do any and all other acts and things and to execute and deliver any and all other agreements, documents, instruments and certificates, all as may be necessary and appropriate to consummate the above mentioned Vehicle Buyers Order, and to perform all of the terms, provisions and conditions of the Vehicle Buyers Order. Savings Clause: Nothing contained herein shall in any manner be deemed or construed to alter, modify, supersede, supplant or otherwise nullify any other Ordinance of the City or the requirements thereof whether or not relating to or in any manner connected with the subject matter hereof, unless expressly set forth herein.

SECTION 3. Severability Clause: If any term, condition, or provision of this Ordinance shall, to any extent, be held to be invalid or unenforceable, the remainder hereof shall be valid in all other respects and continue to be effective and each and every remaining provision hereof shall be valid and shall be enforced to the fullest extent permitted by law, it being the intent of the Board of Aldermen that it would have enacted this Ordinance without the invalid or unenforceable provisions. In the event of a subsequent change in applicable law so that the provision which had been held invalid is no longer invalid, said provision shall thereupon return to full force and effect without further action by the City and shall thereafter be binding.

SECTION 4. Effective Date: This Ordinance shall take effect and be in force from and after its passage by the Board of Aldermen and its approval by the Mayor of the City of Dardenne Prairie, Missouri.
